Sub: Maintenance of Indian Dentist Register for Part 'A' & Part 'B' by the Dental Council of India u/s 18 of the Dentist Act, 1948 - Regarding

Sir,

I am directed to state that the Executive Committee of the Dental Council of India at its meeting held on 4.10.2013 considered section 18(1) of the Dentists Act, 1948 which envisage that Council shall maintain a register of dentists to be known as the Indian Dentists Register and consisting of the entries in all the State registers of Dentists and as per section 18(2) of the Dentist Act, 1948, each State Dental Council shall supply to the Council twenty printed copies of the State register as soon as may be after the 1st day of April of each year, and each Register shall inform the Council without delay of all additions to and other amendments in the State register.

The Executive Committee also observed from past experience that most of the State Dental Councils are not sending the list of dentists of their state, in time and in uniform pattern which is not in accordance with the provisions of Dentists Act, 1948 resulting great difficulty in maintaining of Indian Dentists Register at the office of the Dental Council of India u/s 18(1) of the Dentists Act, 1948.

The Executive Committee after discussion & deliberations decided as under:-

A circular may be issued to all the State Dental Councils to send the up-to-date hard copy and soft copy (excel file .xls) of the list of all existing registered dentists (Part A and Part B separately) of their state, in the following prescribed format and sequence, immediately, so as to enable this Council to compile all the lists of dentists receive from all the State Dental Councils in a uniform pattern, to prepare the Indian Dentists Register.




